- Category 5 College Level (18 years 21 years)

# **ELIGIBILITY:**

Participants must be between 5 years to 21 years to enter this Contest.



#### **HOW TO REGISTER?**

- 1. Entry fee is Rs.100 only (Your registration is 100% going for a cause).
- 2. The registration will be online through www.radiancecharitable.org. Individual students can also participate with the help of parents or teachers or a School can collectively register on behalf of the students.
- 3. The Details of the students participating can be sent in an excel sheet to the organising committee.

#### **GUIDELINES:**

- 1. Entries must follow the competition theme. Only one entry per person. No group participation is allowed.
- 2. The competition is open to all schools in India.
- 3. Participant artwork should not be smaller than 8" X 12" (21cm X 29.7 cm) A4 Size
- 4. The submission must have a high-resolution digital image of the entry (jpeg format, minimum 300 dpi and not exceeding 3 MB). The art sheet should have the Name, Class and School/College name of the participant.
- 5. The art can be created using free hand, pencil, Sketch pens, and Crayons (including water-soluble, pastel, graphite, and charcoal pencils).
- 6. The artwork should not be retouched, and NO OTHER DETAILS should appear on it.
- 7. The Winners will be awarded Cash prizes and E-Certificates.
- 8. The organising committee would verify the paintings before the winners are finalised.
- 9. All the participants will receive the participation E-certificate after the contest.
- 10. The submitted art which does not follow these rules will be subject to disqualification.

#### **JUDGING CRITERIA:**

A selection committee will review artwork submissions based on the following criteria:

- · Interpretation of the theme
- Creativity
- Originality

#### **COPYRIGHT LAW:**

Any artwork that depicts copyrighted images will be rejected. For example, no artworks depicting characters from television shows, movies, video games, or books will be accepted. All artworks must be original ideas and created entirely by the student.

The organisers would hold the right to reject any National award-winning entry if it is found to be violating any rules or conditions of the activity during the verification and replace it with the shortlisted entry. The entries selected in the final judging will be announced ONLINE.
